# **BOARD MEMBER ELIGIBILITY REQUIREMENTS**

# Texas Election Law, Title 9, CH 141, Subchapter A. Sec. 141.001

- 1. Be a United States Citizen:
- 2. Be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable;
- 3. Have not been determined mentally incompetent by a final judgment of a court;
- 4. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities;
- 5. Have resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the following date:
  - For a candidate whose name is to appear on a general primary election ballot, the date
    of the regular filing deadline for a candidate's application for a place on the ballot;
  - b. For an independent candidate, the date of the regular filing deadline for a candidate's application for a place on the ballot;
  - c. For a write-in candidate, the date of the election at which the candidate's name is written in;
  - d. For a party nominee who is nominated by any method other than by primary election, the date the nomination is made; and
  - e. For an appointee to an office, the date the appointment is made; and
- 6. on the date described by Subdivision (5), be registered to vote in the territory from which the office is elected; and
- 7. Satisfy any other eligibility requirements prescribed by law for the office.

#### TX HB 2358 -

- Water code 49.1025 will affect election code 63.001.
- Codifies standards for voters in Ch 49 water district confirmation elections and election held in conjunction with confirmation elections.
- Candidates cannot be:
  - A Developer of property in the district;
  - Is related within the third degree of affinity or consanguinity to a developer of property in the district;
  - Is an employee of a developer of property in the district
  - Has resided in the district less than 30 days or
  - Received monetary consideration from a developer of property in the district in exchange for the person's vote.

#### East Cedar Creek FWSD Bylaws state:

 Directors shall be property owners and residents of the State of Texas and of ECCFWSD in Henderson County, TX.

### **ABOUT OUR BOARD OF DIRECTORS**

The District's governing authority is vested in a seven-member Board of Directors. Board members qualify to serve by execution of the constitutional oath of office. Board members are elected for four-year terms with three or four positions elected every two years. In a case where there is a vacancy of an unexpired term or new term where there were no candidates for the seat the Board of Directors will normally appoint a new director in the following month.

Our Board Meetings are held on every third Wednesday of the month unless otherwise posted (see Public Info section on this website). These meetings are open to the public and there is always a Public Comment section on the agenda. The Public Comment section is for the Public to address non-agenda items and request that their item to be considered on a future agenda. Individuals are limited to a maximum of three (3) minutes. The Board cannot deliberate on non-agenda items.
